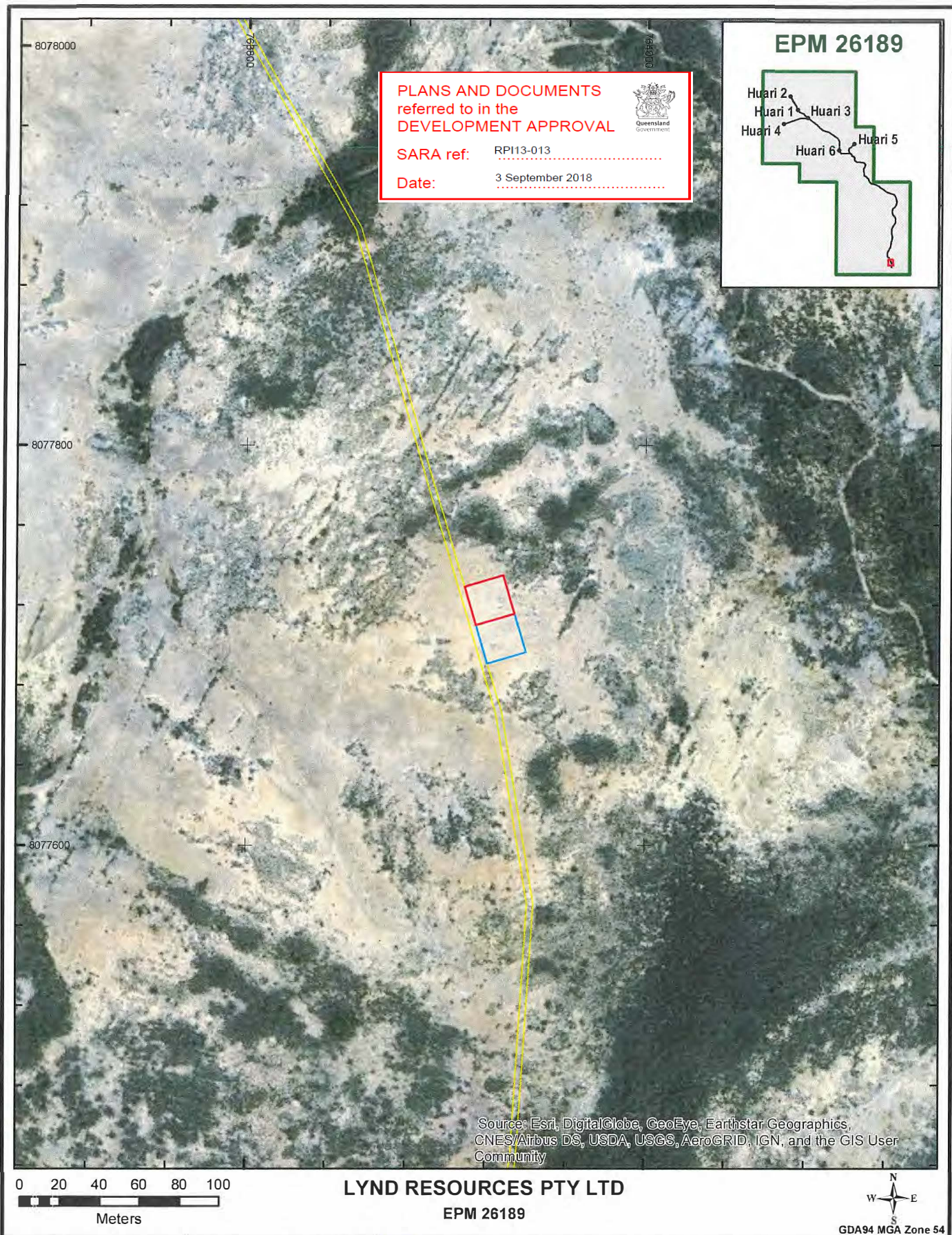

Figure 8: Schematic of proposed drill pad

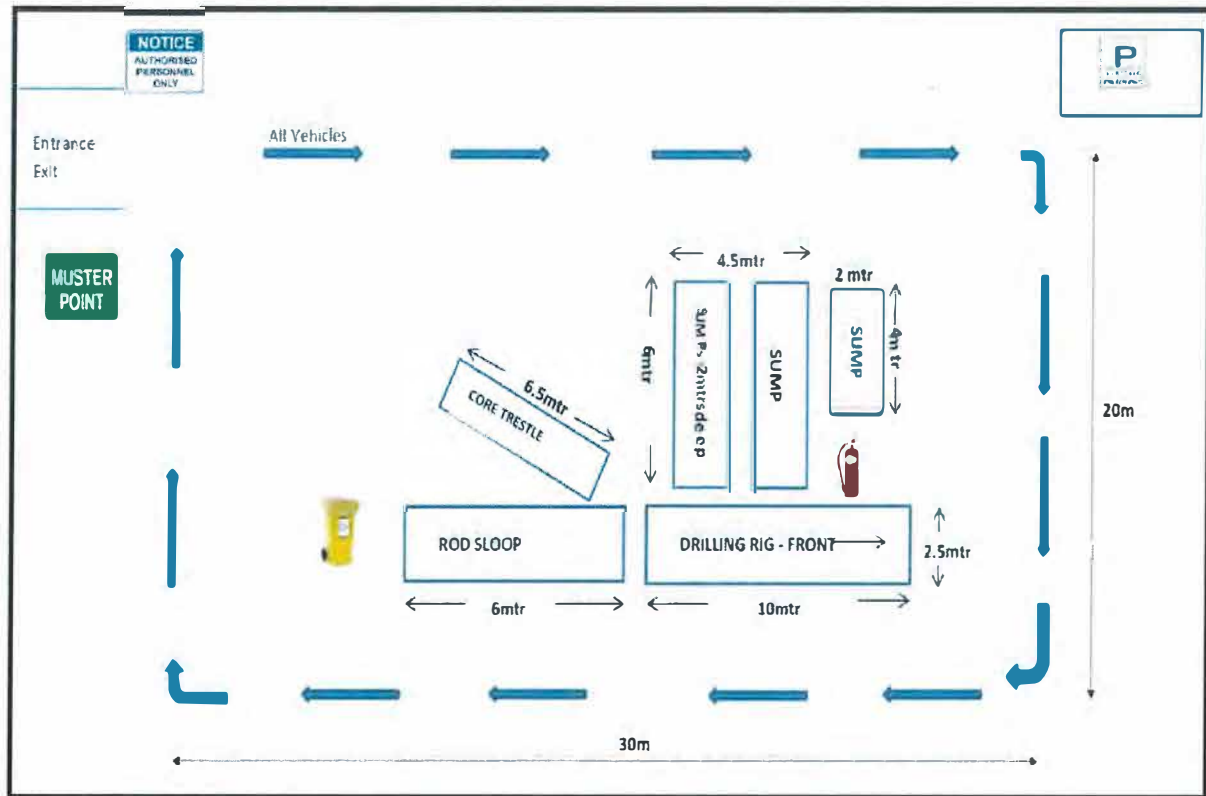


Figure 9: Schematic of Fuel Storage and Laydown Area

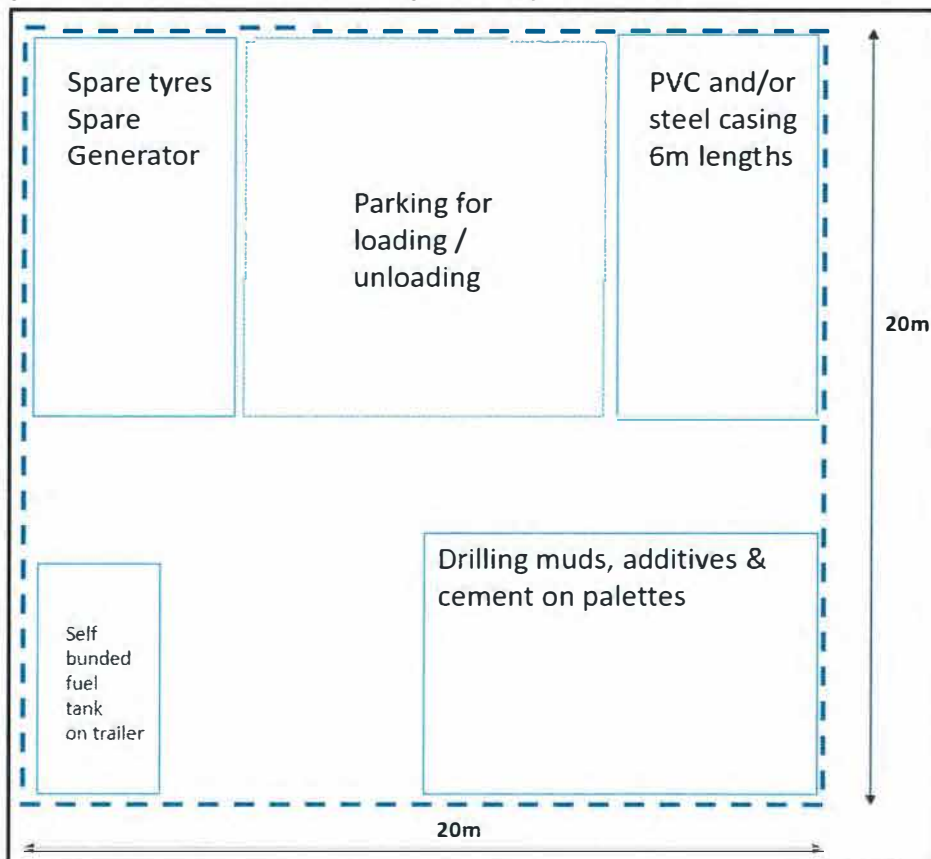
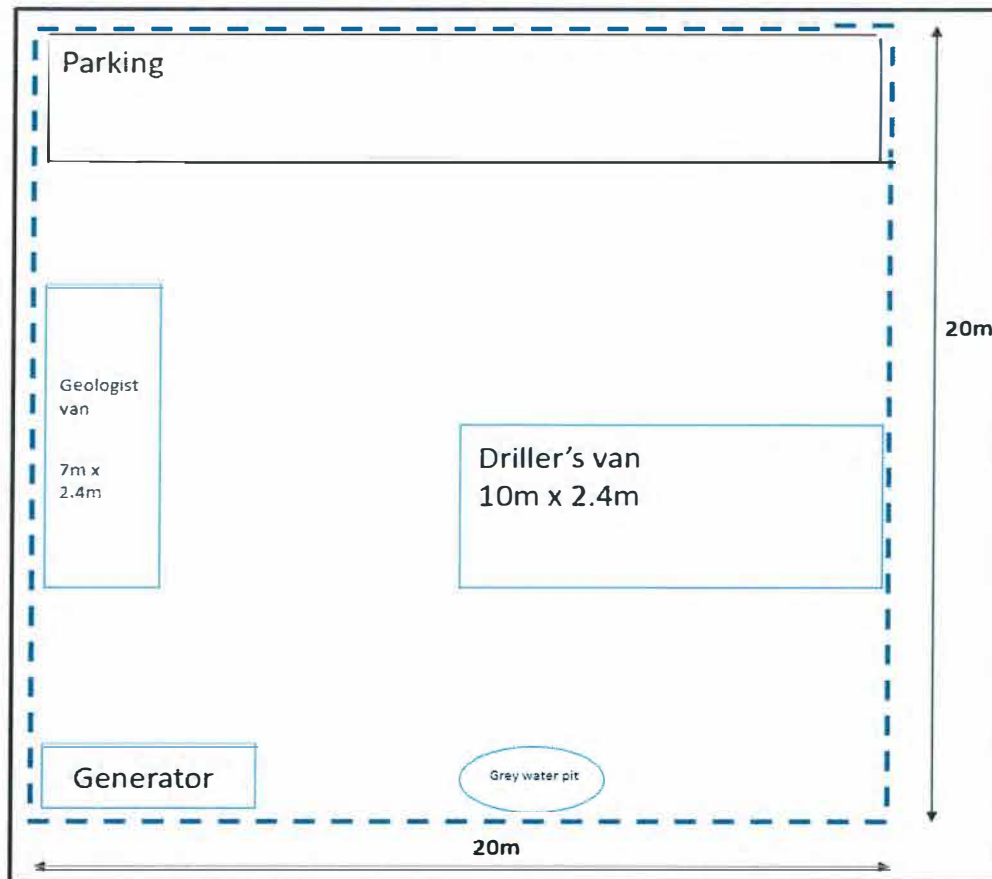
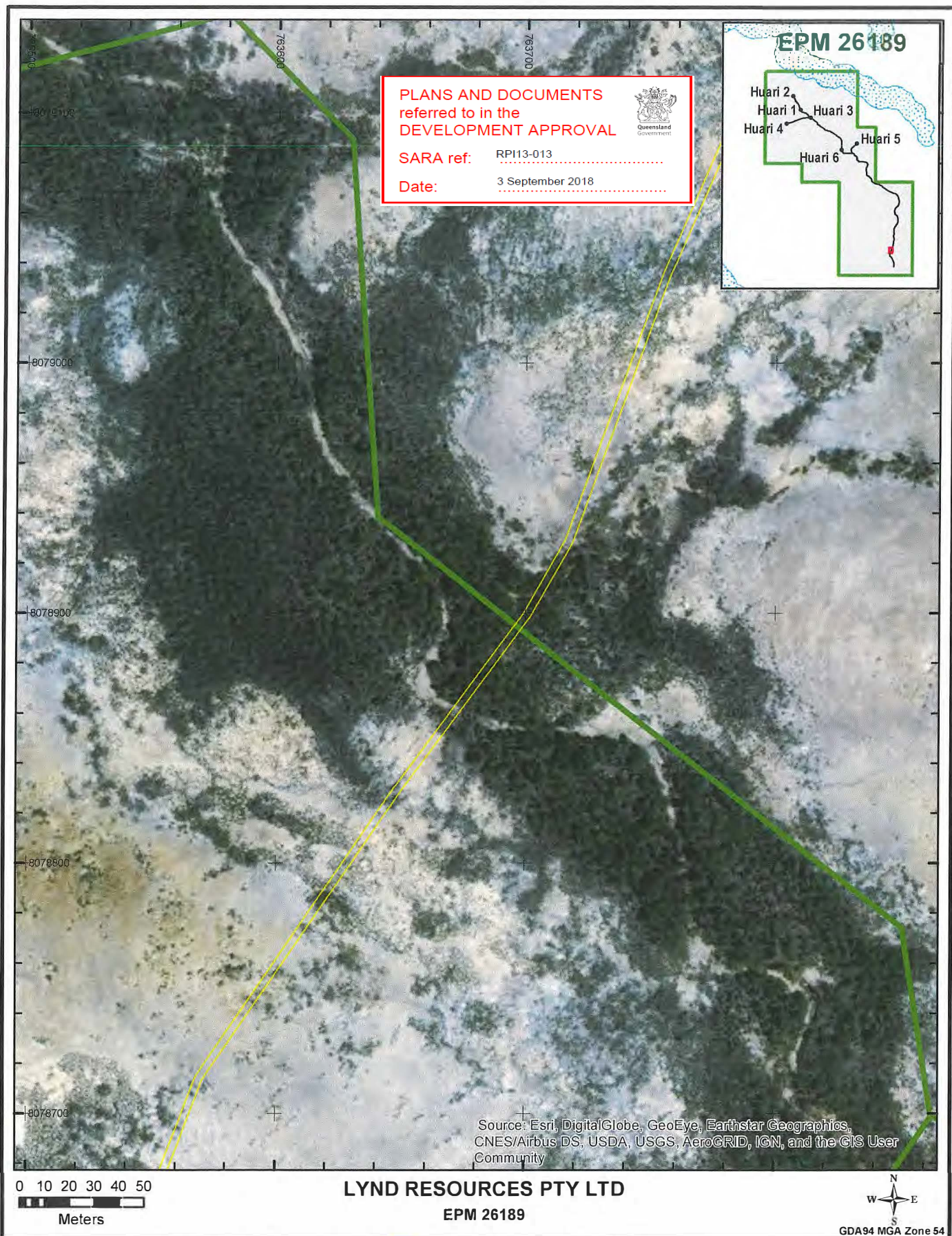
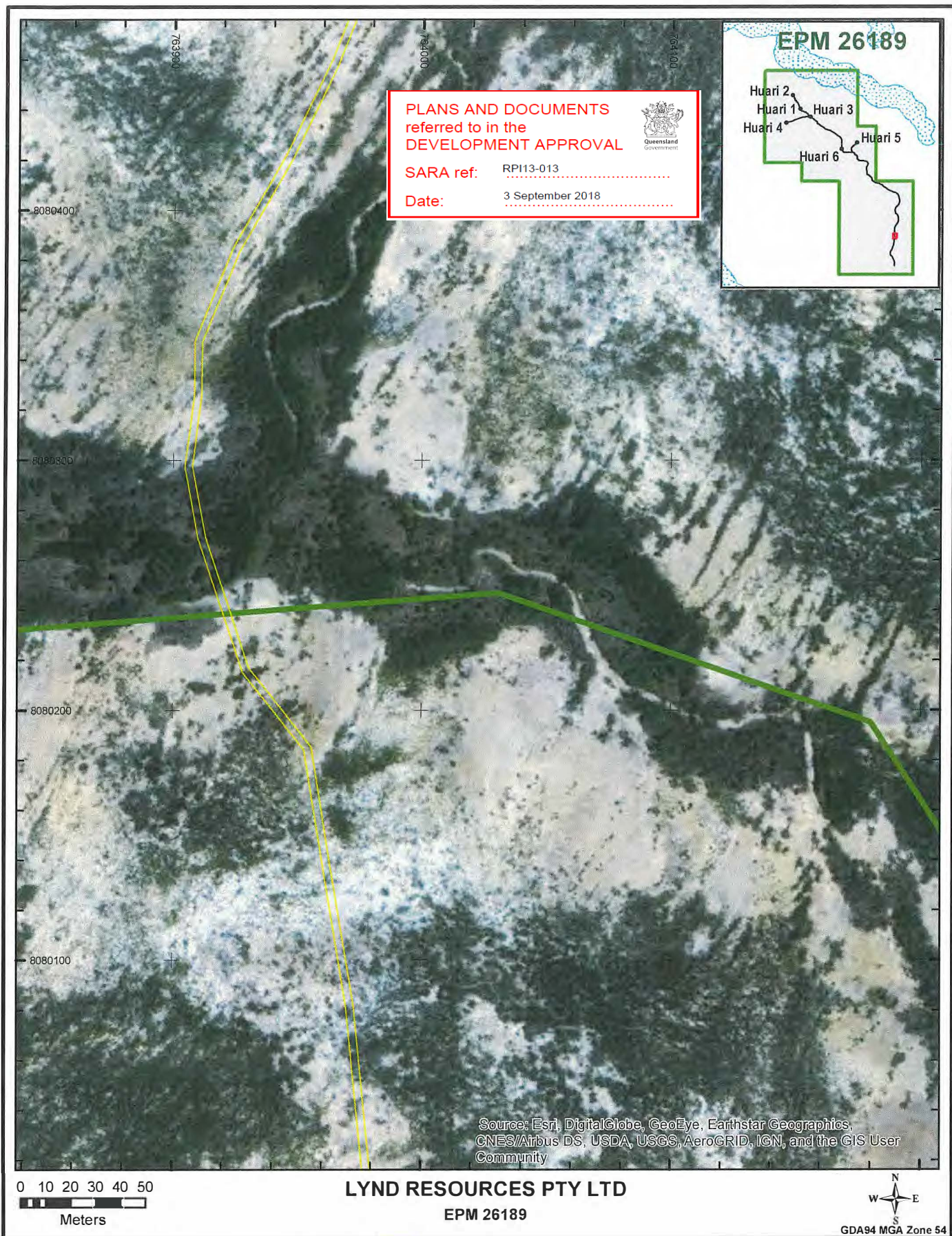






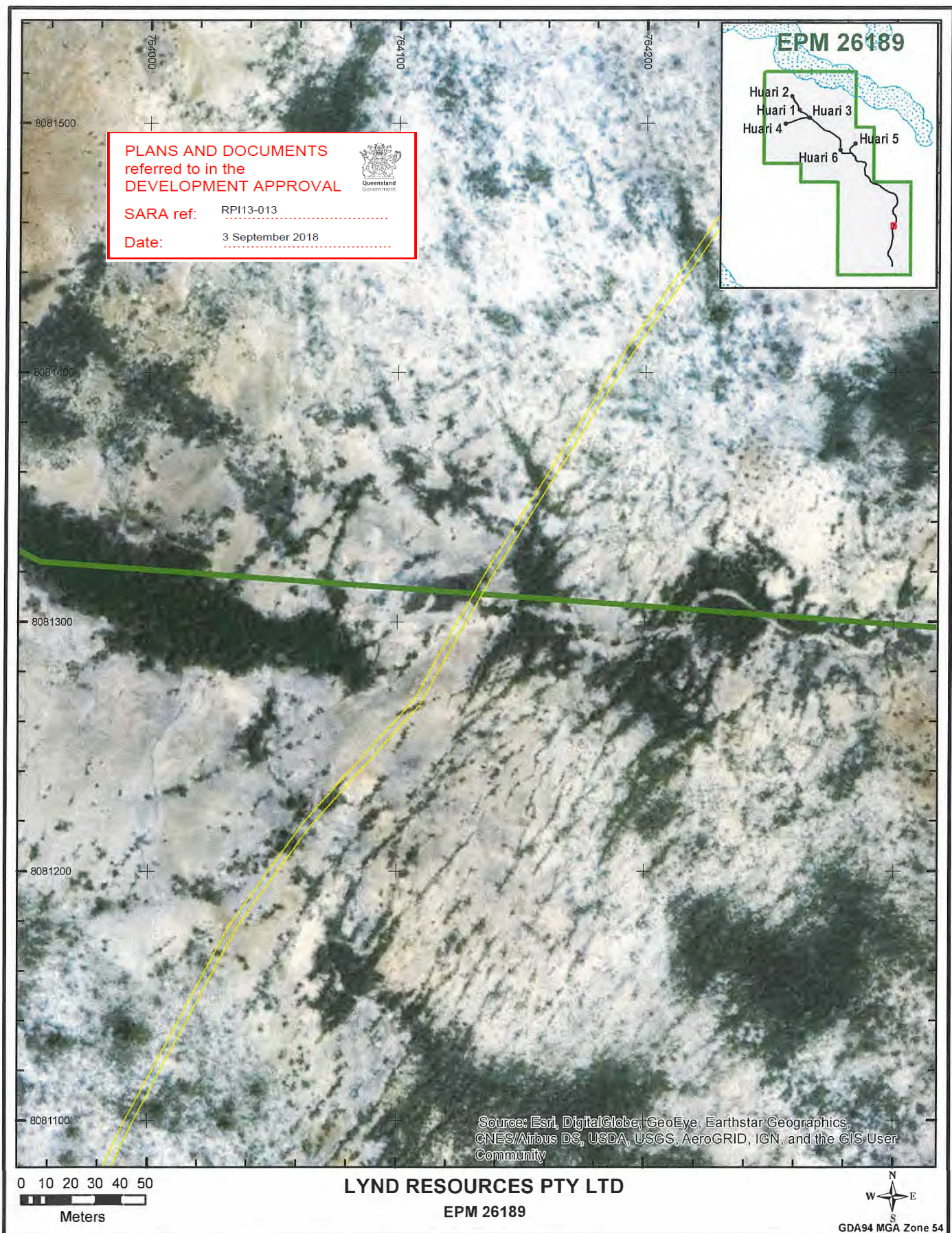
Figure 10: Schematic of Temporary Mobile Campsite





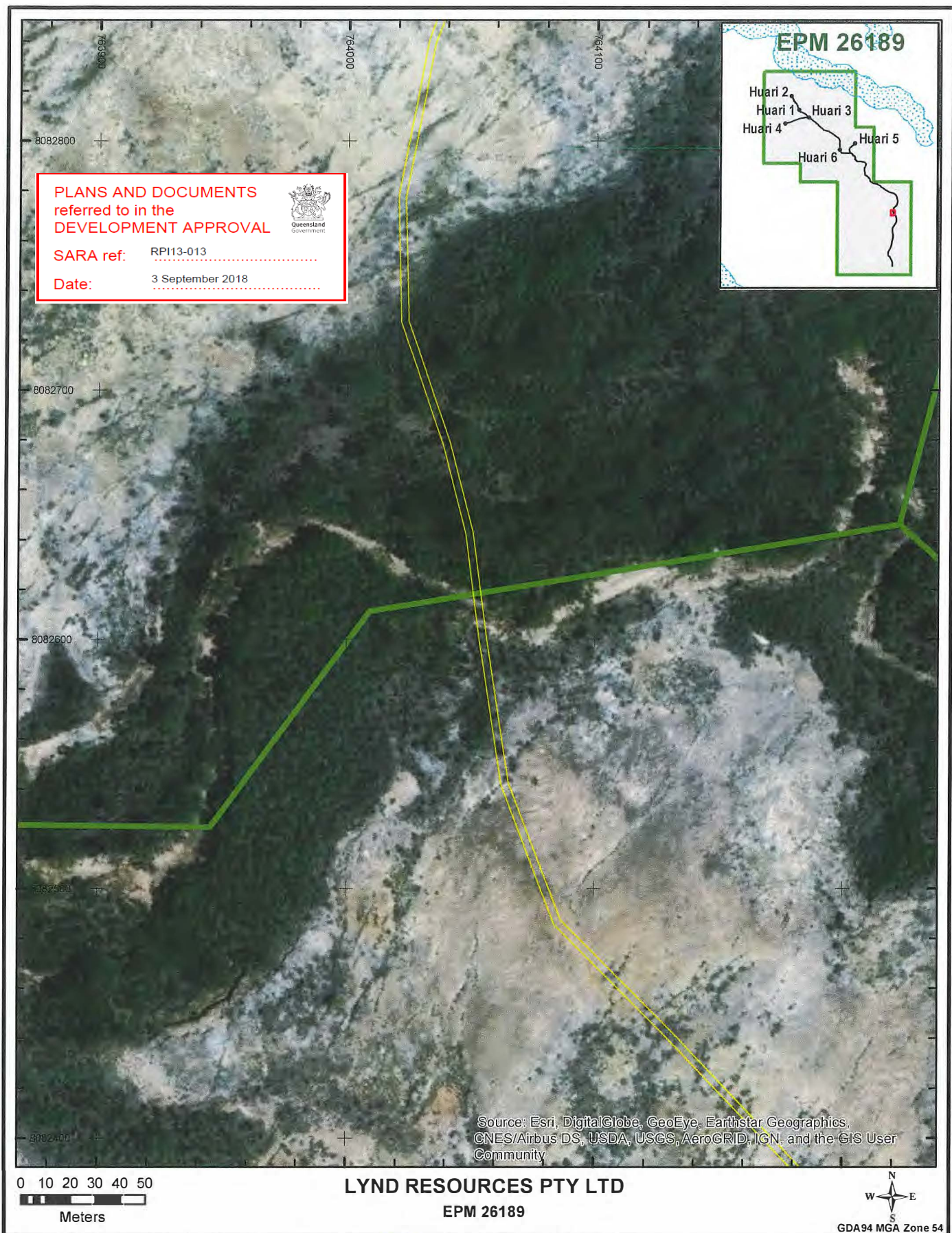

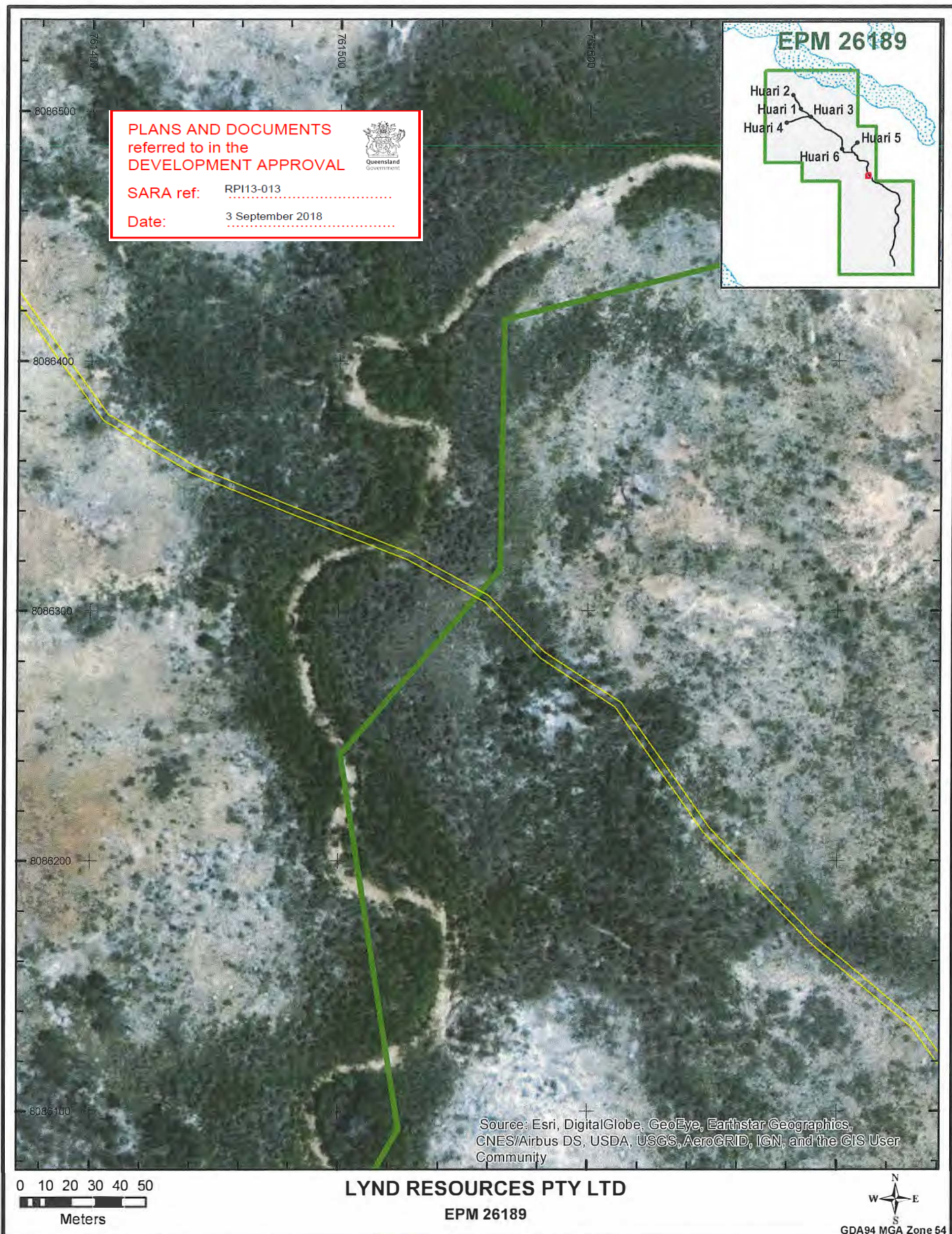

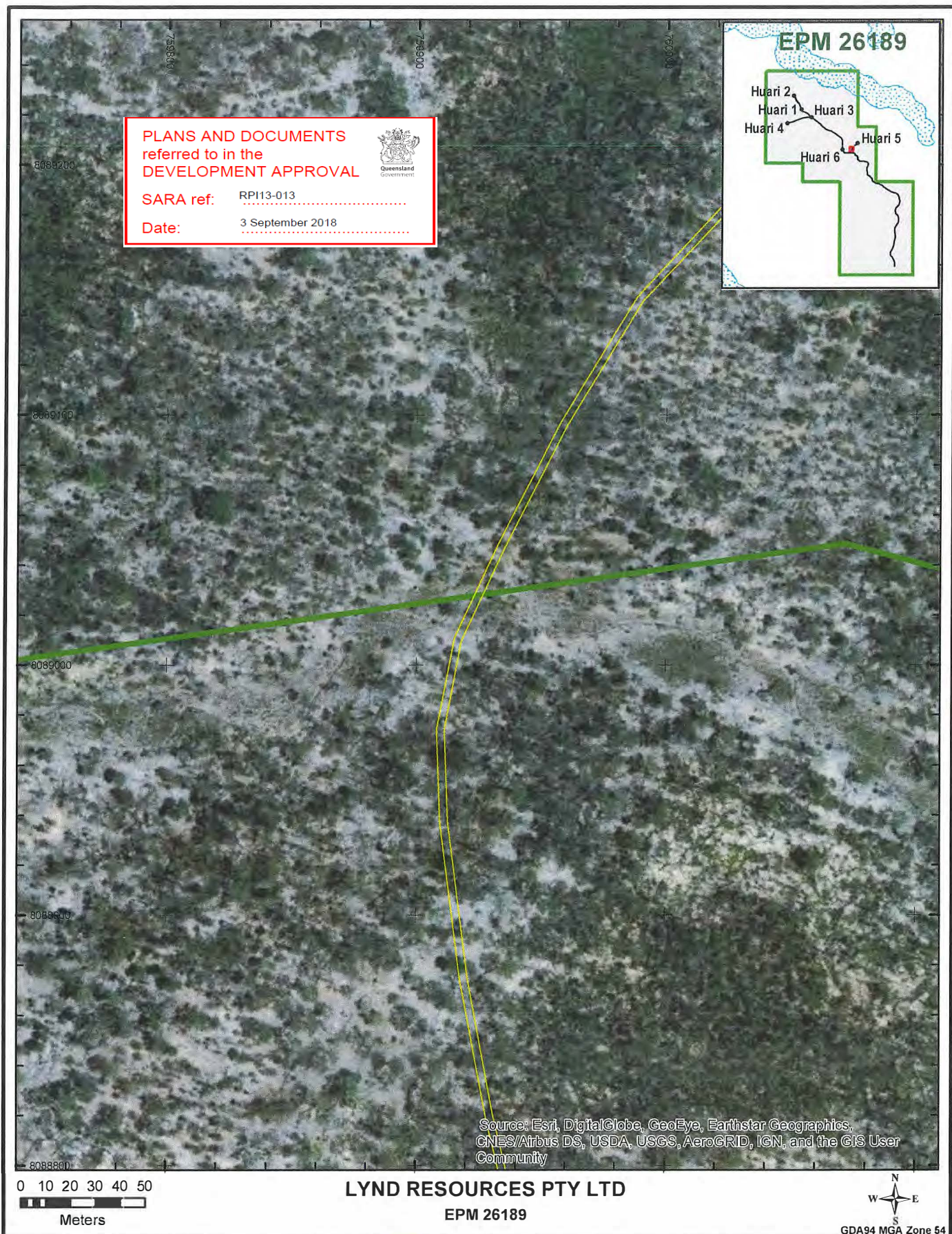
