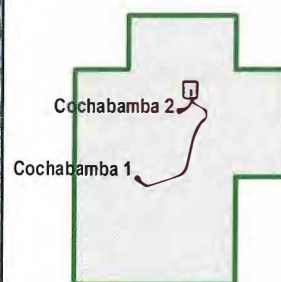

Figure 7: Schematic of proposed drill pad

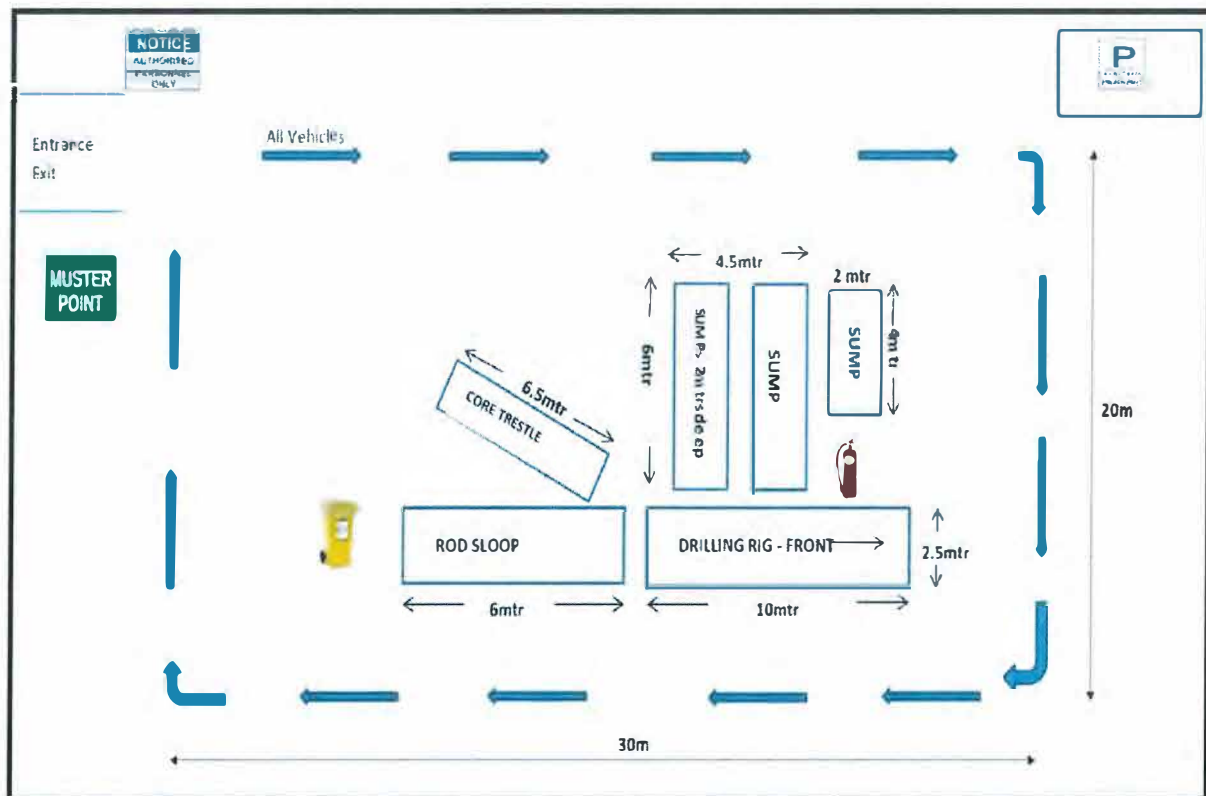


Figure 8: Schematic of Fuel Storage and Laydown Area

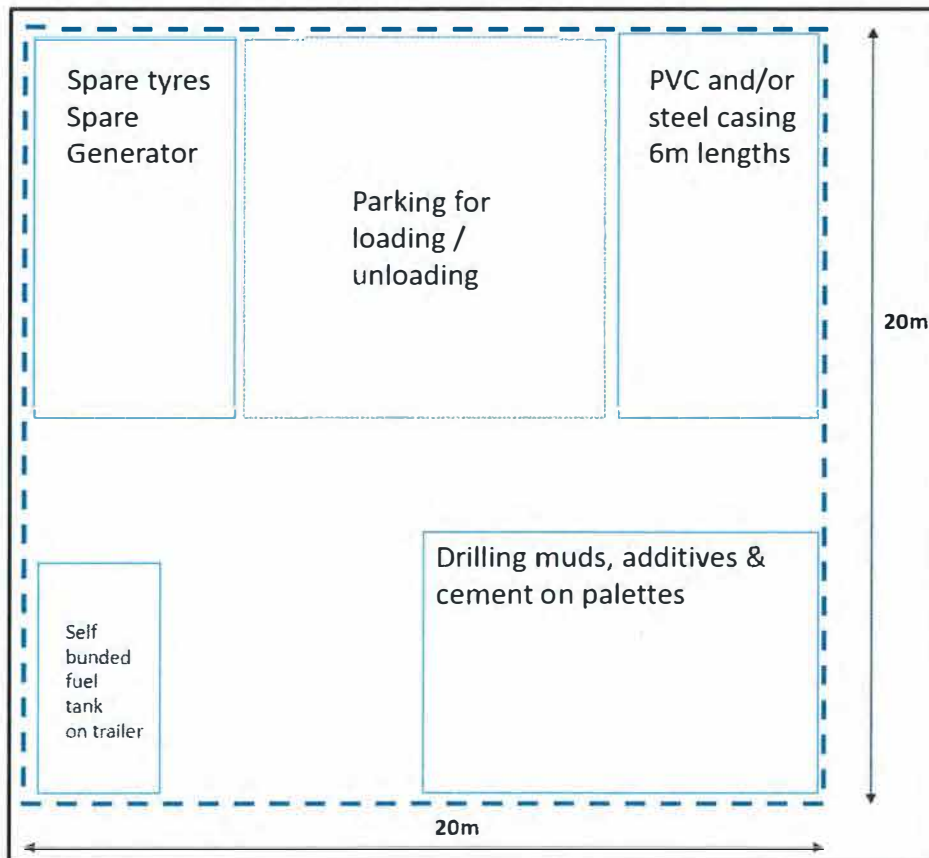
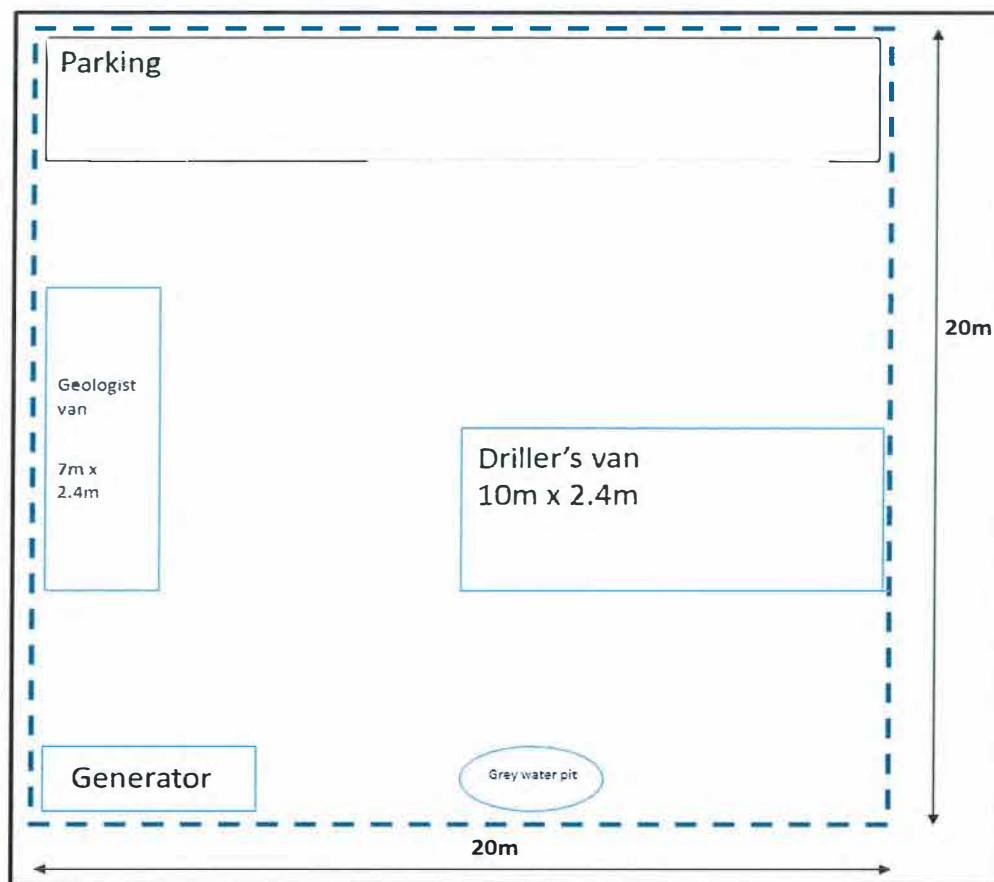
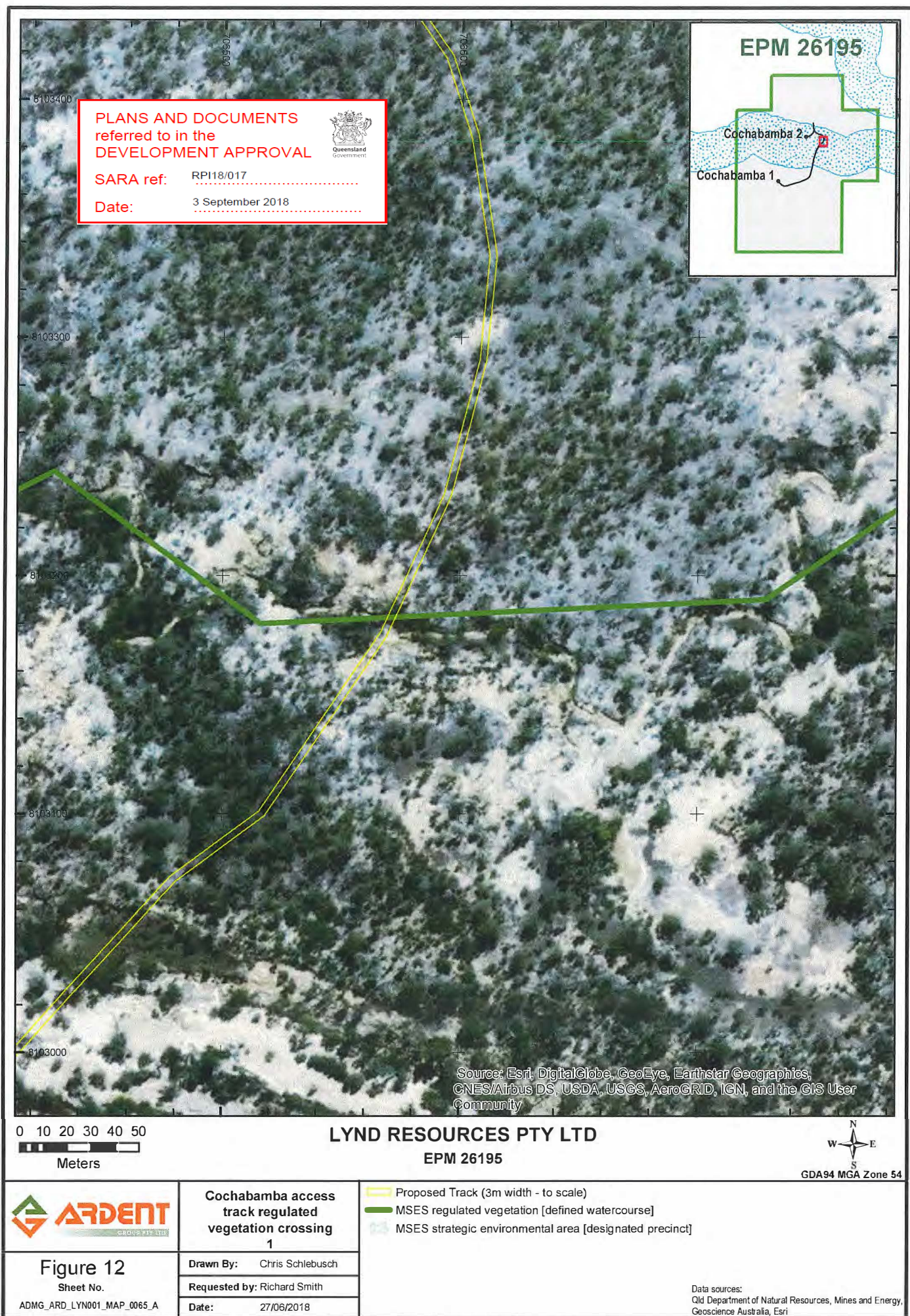



Figure 9: Schematic of Temporary Mobile Campsite
