# Attachment A

## Information required for assessment against section 49 of the RPI Act

#### In relation to land ownership

According to the land titles for the two impacted properties containing SCL, neither are owned by the applicant (BG International (Aus) Pty Ltd ACN 130 856 843). The two owners of land containing SCL that are proposed to be impacted by the resource activities are:

- ELIMATTA PASTORAL PTY LTD
- QGC PTY LIMITED

Under s30(2) of the RPI Act, the applicant must give a copy of the application to the owner of the land within the prescribed timeframe.

1. Provide evidence that QGC PTY LIMITED and ELIMATTA PASTORAL PTY LTD were given a copy of the application under s30(2) of the RPI Act.

The application does not contain evidence that the property owner QGC PTY LIMITED has entered into a voluntary agreement about the impacts of the proposed activities on their property (SCL).

2. Provide evidence to show that the applicant has taken all reasonable steps to consult and negotiate with QGC PTY LIMITED to reach a voluntary agreement about the impacts of the proposed activities on their property.

Note: Where agreement with the land owner has not been reached, permanent impact on strategic cropping land on a property (SCL) is limited to two percent of the strategic cropping land on the property (SCL).

#### In relation to RPI Act, Schedule 2, Part 4 Required Outcome (RO) 1

The application purports to demonstrate compliance with RO1. However, insufficient information has been submitted to sufficiently demonstrate that Required Outcome 1 can be satisfied. Specifically, the initial assessment has identified the following issues in the RPS report: *Strategic Cropping Area Criteria Assessment Report: QGC Charlie Field Compression Station PR111136-68 August 2015*:

- a) The report includes laboratory-derived particle size analysis data for the soils from the sampled sites that is inconsistent with the:
  - identification of the soils as Vertosols (i.e. in general, Vertosols by definition need to have a clay content of >35% throughout the solum);
  - soil characteristics evident in the photographs of the exposed soil profiles;
  - cation exchange capacities reported in the laboratory analysis data for those same soils; and
  - expected characteristics of soils in that locality.
- b) There is significant between-site variability evident in a number of the reported chemical and physical attributes, which could suggest that either:
  - the soil landscape is more complex than the submitted report would suggest (i.e. there is more than one mappable soil unit present); or

• if not presently evident, then prior to clearing and subsequent development the subject land was affected by gilgai, and the differences observed between sites reflects sampling of different elements of those gilgai at the different sites (e.g. a gilgai mound sampled at one site and a gilgai depression at another).

When determining soil depth, the definitions of weathered rock and soil depth provided in section7 and section14 in Schedule 3 of the Regional Planning Interests Regulation 2014 must be used. It is unclear from the description and photograph provided of the soil profile at site CH\_AN1 that what is described as a C horizon meets those definitions.

- 3. Provide sufficient information to demonstrate compliance with either:
  - i) RO1 of Schedule 2, Part 4 of the RPI Regulation, with particular reference to matters a) and b) above; or
  - ii) RO3 of Schedule 2, Part 4 of the RPI Regulation.

The information provided should be in accordance with RPI Act Guideline 08/14, and in particular Section 3.4, which provides guidance on soil sampling and analysis requirements in gilgai-affected terrain.
