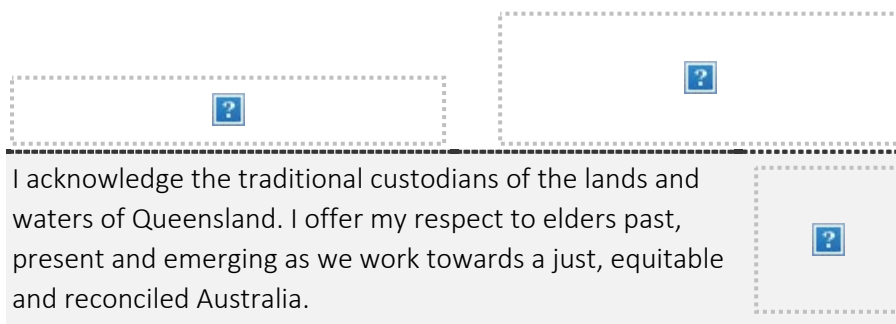

**Re: Requirement Notice for the application to amend RPI17/001**

Our consulting engineers engaged to prepare a Traffic Impact Assessment (TIA) have advised us that they are still awaiting current traffic volume numbers to be provided by the Rockhampton Regional Council so they can finalise the TIA. I have approached the Council to see if there is any assistance Heritage Minerals can provide to facilitate the completion of a traffic survey. As per the request for additional information, the TIA is a requirement for us to satisfy the additional information request.

As such, Heritage Minerals request a 6 week extension to the additional information request deadline.

Also, as per our recent phone conversation, I can advise that Heritage Minerals have made minor changes to their project plans as follows:

- the addition of a car parking facility adjacent to the proposed new Gordon Lane access road within DoR land but outside the mining lease. We have made contact with residents around this location to advise them of Heritage Minerals proposed plans for the Gordon Lane access. We haven't received any objections to date but we will continue to engage directly with local residents.
- As stated in our PLA amendment application, Heritage Minerals were proposing to place initial tailings into the open cut pit while a Tailing Storage Facility dam was constructed in Sandstone Gully. Heritage Minerals has now reverted to the original concept of a 2 stage Tailings Storage Facility dam which will retain all tailings for the proposed mining operation. It was this concept that was included in Norton's PLA approval. These aspects will be incorporated into an amended Environmental Authority application in preparation by Heritage Minerals..
- There are no plans for Heritage Minerals to construct and operate a new Water Treatment

Plant facility to treat contaminated water for release into the Dee River. These activities will remain under the responsibility of the Department of Resources. Should this situation change in future and Heritage Minerals wish to construct new water treatment facilities, they will be subject to a new RIDA application.
